## 1. Select an appropriate identification

### Acceptable forms of Identification (ID)

*Note: All IDs must be current and valid. If your ID shows your address, it must be a Colorado address.*

A valid Colorado driver's license, except one issued to an individual that is not a citizen of the United States;	A valid student identification card with a photograph of the eligible elector issued by an institution of higher education in Colorado;
A valid identification card issued by the Department of Revenue;	A valid identification card issued by a federally recognized tribal government certifying tribal membership;
A valid United States passport;	A valid employee identification card with a photograph of the eligible elector issued by any branch, department, agency, or entity of the United States government or of this state, or by any county, municipality, board, authority, or other political subdivision of this state;
A valid United States military identification card with a photograph of the eligible elector;	
A valid veteran identification card with a photograph of the eligible elector issued by the United States Department of Veterans Affairs Veterans Health Administration;	A valid pilot's license issued by the Federal Aviation Administration or other authorized agency of the United States;
A valid Medicare or Medicaid card issued by the United States Health Care Financing Administration;	Written verification that you are a resident of a group residential facility, are committed to the Department of Human Services, or are in the custody of the Department of Youth Corrections;
A copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows the name and address of the elector;	Written correspondence from the county sheriff or his or her designee to the county clerk indicating you are confined in a county jail or detention facility.
Certified documentation of naturalization;	

## 2. Make a photocopy of that identification

If your identification shows an address, it must be a Colorado address.

## 3. Return the copy of identification

Dear Voter,

We have received your voted ballot for the November 6, 2018 General Election. Under Colorado law, you were required to return a photocopy of acceptable identification (ID) along with your ballot. Unfortunately, your return envelope did not contain an ID.

In order for your ballot to count, you must return a photocopy of ID by the close of business on Wednesday, November 14, 2018. If your ID lists an address, it must be a Colorado address.
